The same shall be in the form of demand draft on any Nationalized Bank/ schedule Bank in favour of the Municipal Commissioner, Rourkela Municipal Corporation, payable at Rourkela, Orissa. Scan copy of the demand draft shall be submitted in cover - I of the online.

- Hard copies as detailed in DTCN must be submitted on or before 22.2.2018 up to 5 PM.



7. Bids shall be opened at 15.00 hours on 23.2.2018 in the office of the undersigned in the presence of the bidders or their Authorized agents who wish to attend. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working days at the same time and venue.
- Financial instrument such as Cost of bidding document and bid security in original & copy of other documents like No relationship affidavit and Bid participation affidavit shall have to be deposited before the tender opening authority in between the date and time of closing and one hour before opening of the tender on working days failing which the bids shall be summarily rejected.
8. The Bid document shall contain scan copy of (a) Registration certificate, (b) PAN, (c) GST Registration (as applicable), (d) Cess certificate from Dist. Labour office and other document required as per DTCN and special condition if any.
9. The authority reserves the right to cancel any or all bids without assigning any reason thereof.
10. As per provision under OPWD Code e-Tendering chapter under clause no.14 (vi) the Procurement officer-publisher (undersigned) shall not be responsible for any postal delay /or non receipt of original copy of bid security on or before specified date and time. Non submission of bid security within the designated period shall debar the bidder from participating in the on-line bidding system and his portal registration shall be blocked. His name shall also be informed to the registering authority for cancellation of is registration as Contractor. VII. Contractor exempted from payment of EMD will be able to participate in the tender directly by uploading documentary evidences towards his eligibility for such exemption.

N.B: (1. Bids of Non performing Municipality contractors will be rejected and bids of Contractors having incomplete work against previous work order of Rourkela Municipality now Rourkela Municipal Corporation will not be considered. 2. The hard copy documents and financial instruments along with BID CONFIRMATION CERTIFICATE in original should be dropped in the tender box indicating the name of the work and BID ID No. for which bid submitted within schedule date & time otherwise the bid will be rejected.
