3. The Street Vendor must have business in 200mt. distance in and around Subashbose Park.
4. The Street Vendor must Pay Security deposit, Monthly rent with GST and Sanitation Fees as per the Street Vendor Act.
5. Eletricity and Water bill also borne by the Street Vendor.
6. Mission Shakti Group also applied for the Stall having experience in preparation of food and have Food License.
7. In case no Street Vendor found as per the Criteria then Mission Shakti Group will engaged for the allotment of Stall.
