

BID PAPER

1. The intending bidder shall have to furnish EMD of Rs. 20,000.00(Rupees twenty thousand) only in shape of DD drawn in favour of Municipal Commissioner, Rourkela Municipal Corporation along with the quotation as per the prescribed format given below.
2. The successful bidder shall have to install temporary shed at each location with manpower provision of water pots, glasses, jugs, fixing of banner and manpower for distribution of drinking water from 9 AM to 4 PM daily with effect from opening of the Jalachhatra Center to 15.6.2018
3. Rourkela Municipal Corporation will provide the drinking water to all the Jalachhatra Centers.
4. The successful bidder shall enter into an agreement for Jalachhatra Service.
5. The list of locations of Jalachhatara Centres will be provided by RMC.
6. The payment of bill towards Jalachhatra Service shall be paid to the successful bidder only after satisfactory performance report by the authorized officer of RMC.
7. All grievances in respect of functioning of Jalachhatra shall be attained by the bidder within 24 hours otherwise penalty @ Rs.100/- per day shall be deducted from the bill raised for the Jalachhatra concerned.
8. The lowest quoted rate in cumulative will be considered.
