TERMS & CONDITIONS

Tender for Supply of Gym equipments to the Biju Patnaik Indoor Stadium, Panposh, Rourkela

Commissioner, Rourkela Municipal Corporation (hereinafter referred to as the Purchaser), invites tenders from established and reliable manufacturers or their authorized agents (having an average annual turnover of not less than Rs.1 Crore in the last three financial year) for the supply as set forth in the "Schedule of Requirements".

1. The Tender Enquiry shall be submitted in **two separately sealed envelopes (A-Technical and B- Financial Bid)** with a covered envelop super scribed on the top left corner of the envelopes as "**TENDER FOR SUPPLY OF GYM EQUIPMENTS FOR BIJU PATNAIK INDOOR STADIUM**" and addressed to the Commissioner, Rourkela Municipal Corporation, Uditnagar, Rourkela, Dist.-Sundargarh (Odisha), PIN-769012.
2. The bidder has to submit Earnest Money Deposit (EMD) amounting to Rs.120,000/- (Rupees One Lakh Twenty Thousand Only) in the form of Demand Draft in favor of Commissioner, Rourkela Municipal Corporation, Rourkela. The EMD received from the tenderers will be returned without interest immediately after the process of award of contract is over. The bids received without EMD shall not be considered for technical evaluation.
3. **Performance Guarantee-** Performance Guarantee/ Security Deposit of 10% of total value (Gym equipment + AMC) will have to be deposited within 20 days of placing order in the form of Bank Guarantee from a Nationalized Bank. This shall be valid up to 90 days beyond warranty/ AMC period. Performance Guarantee will be returned without any interest after successfully completion of AMC period. This amount, however, be confiscated in case of refusal or failure to provide satisfactory services or backing out in midstream.
4. **The Financial Bid** form shall be submitted in **Envelope – 'B'**.
5. **Payment:** 100% Payment will be released to the agency after satisfactory supply and installation of goods, supplied as per the supply order as well as on verification of the goods by the Technical Committee to be constituted by the RMC. The quality/ make, brand of equipments should be strictly as per financial quotation. No advance payment shall be released. The payment of AMC will be made on yearly basis after satisfactory completion of said service. Release of Payment will be made through Core Banking / RTGS mode.
6. Both the Envelopes should be clearly marked as **Envelope A & Envelope B** with the words "**TENDER FOR SUPPLY OF GYM EQUIPMENTS FOR BIJU PATNAIK INDOOR STADIUM**" super scribed on the top left corner of the envelopes which should also show the name and address of the bidder.
7. The **GYM EQUIPMENTS** and accessories should meet the exact specifications specified in the tender document.
8. In case of any doubt with regard to the quality and genuineness of the material/ equipments supplied, the expenditure on getting such doubtful material tested by an appropriate agency will be borne by the tenderer.

9. Detailed specifications with the mention of make and model/ Version of each item should be clearly given supported by the illustrated pamphlets wherever possible. The accessories included in the equipments should also be clearly mentioned. The installation and operationalization of GYM equipment is the responsibility of the bidder.
- 10. Only items having standard certified ISO/ ISI etc shall be accepted.**
11. The rate quoted should be inclusive of all of taxes including GST, packing charges, transportation, Insurance, Installation charges and any other incidental charges and should be clearly indicated for each item separately in the Financial Bid. The equipments should be delivered at Biju Patnaik Indoor Stadium, Panposh, Rourkela. The rate quoted by the tenderer should be valid till one year from the date of opening of financial bid.
12. Any other Govt. charges as applicable from time to time will be borne by the Bidder.
13. The payment will be made to the bidder are subject to deduction of tax as per the Government Rule from time to time.
14. Quantity of materials as specified in the tender schedule may be varied as per the requirement.
15. **Penalty clause (i)** - The delivery period of the GYM equipment shall be 1 months from the date of issue of supply order. In case of delay, the penalty @1% of the total amount per month will be charged for delayed period and which would not be more than 3 months from the date of issue of supply order.
16. **Penalty clause (ii)** - The firm has to repair GYM equipment (on site) at Biju Patnaik Indoor Stadium, Panposh, Rourkela within 10 days after lodging the complaint. In case of delay, the penalty would be charged @ 1% of cost of item per day for delayed period.
17. Complete user, technical and service manuals/ installation drawings/ documentation and spare parts catalogue are to be provided along with the supply of the item.
18. Commissioner, Rourkela Municipal Corporation will have the right to reject any or all the bids without assigning any reason thereof at any stage.
19. **Evaluation of Quotations:** Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e (a) are properly signed and (b) confirm to the specification, terms & conditions. Quotations will be evaluated for all the items including AMC Charges taken together given in the quotation format.
20. **Award of Contracts:** Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered reputed make / model with lowest quotation price.
21. Bids received without E.M.D, and incomplete bids or bids having cuttings/over writings is liable to be rejected.
22. The supplies received, if found not as per the specification are liable to be rejected.
23. In case the bidder fails to supply the desired goods within the stipulated time period, Rourkela Municipal Corporation shall have the right to purchase the same from other sources.
24. In case of late/ delayed supply of ordered Gym equipments Rourkela Municipal Corporation has right to cancel the order and that will be treated as violation of contract.

25. Rourkela Municipal Corporation will be legally competent to cancel the contract of supply and also take any other action against the supplier including imposing any penalty on the supplier during pendency and till the final execution of the contract of the supply. In case the supplier is ever found to have committed any fraud against Rourkela Municipal Corporation in supplying the material or indulge in any other malpractices thereof causing any financial losses during contract period. Legal action will be taken against the supplier as per law.
26. The contract can be terminated or cancelled summarily by Rourkela Municipal Corporation in whole or in part any time without assigning any reason, if the supply made by the manufacturer / supplier is found not according to the approved specification or in case supply is not received within stipulated time.
27. There should be no legal suit/ criminal case pending or contemplated or legal notice having been served to this effect against the Proprietor of the Agency or any of its Directors (in case of Pvt. Ltd. Company) on grounds of moral turpitude or for violation of any of the laws in-force and should not be black listed by the any Government organization. The self-certification as per **Annexure-III** should be enclosed.
28. The Bidder should furnish all the information as required in the Technical Bid form.
29. Rourkela Municipal Corporation will have the right to forfeit Performance Security, if the terms and conditions of the Tender are not adhered to by the supplier or in case of breach of Contract.
30. In case any dispute arises in regard to the tender, the decision of the Commissioner, Rourkela Municipal Corporation will be final and binding.
31. In case of litigation, the courts at Rourkela only will have jurisdiction for deciding case according to the relevant Indian laws in force.
32. The technical bid of the bidders will be opened first and the financial bid will be opened only of the bidders whose technical bid is accepted / qualified.
33. The bidders have to quote the unit price of individual items (as per the list) under each category of goods and indicate the total package value under each category of item i.e Gym Equipments. It may be mentioned that purchase orders shall be placed on the basis of the cost quoted by the bidders under each category of goods intended to be procured.
34. The bidders are required to quote the price of all the items in each category, failing which their offer shall not be considered.
35. It must be noted that this is just an enquiry and does not amount to any commitment on the part of Commissioner, Rourkela Municipal Corporation to order purchase of any or all items as per the list. The decision of the authority in this regard would be final.
36. The tenderer/authorized person(s) should sign on each page of the bid document as a token of authenticity of the same.
37. Tender (s) received after due date & time shall not be accepted and Rourkela Municipal Corporation shall not be responsible for delay in postal delivery or any other reasons.
38. Supply of the placed order in part will not be accepted.

39. **Language of Bid:** *The Bid, as well as all correspondence and documents relating to the Bid exchanged by the Bidder and the RMC, shall be in English including Previous work orders, Contract agreement copy, Assignment completion certificate etc.*
40. Conditional tenders will not be accepted.
41. **WARRANTY:** The vendor will provide one year onsite comprehensive warranty for the Gym equipment being supplied irrespective of manufacturer warranty. Any failure in the equipment or a subsystem thereof should be rectified within a maximum period of 10 days of lodging a complaint. Any defect attributable to poor workmanship or use of substandard quality material during manufacturing process must be replaced with new one free of cost at site by the supplier irrespective of the guarantee/ warrantee clauses between the supplier and his dealer OEM. No additional charges shall be paid to him by the RMC. Warranty certificate against all the equipments developed defects covering warranty period, which commence from the date of installation, shall be given at the time of supply of the equipments.
