In pursuance of the provision under Section 2 (d) of the Disaster Management Act, 2005 the State Government have declare COVID-19 as a Disaster for the State of Odisha and authorised the Disaster Management Authorities, State Executive Committee and public authorities to take such action under the Act, as may be required, for management of the such disaster.

Similarly under sub section 1 and 2 of Section 25 of the Disaster Management Act 2005, the State have also constituted the District Disaster Management Authorities with following members:-

In exercise of the power, conferred under Section 33 of the Disaster Management Act, 2005, I do hereby authorise the following official of the district to take such measures, as it may be necessary in the interest of life, health and safety of the general public, for the prevention or mitigation of COVID-19 disaster,

1. Project Director, DRDA, Sundargarh
2. Superintendent of Police, Sundargarh & Rourkela,
3. DFO, Sundargarh/ Bonai/ Panposh
4. Additional District Magistrate, Sundargarh/Additional District Magistrate Rourkela,
5. All Sub Collectors ,
6. CDM & PHO, Sundargarh, CMO, Rourkela,
7. All Tahasildar of Sundargarh district,
8. All BDO of Sundargarh district and
9. All Executive Officer of Municipalities of Sundargarh district
10. District Education Officer, Sundargarh/ District Welfare Officer, Sundargarh
11. District Sports Officer, Sundargarh

They are authorised as per Disaster Management Act 34 (C) and as per Letter No. 7730/H dt.13/03/2020 of Principal Secretary to Government, Health and Family Welfare Department, Govt. of Odisha regarding Management of COVID-19 Pandemic to:-

1. Regulate, restrict and, if necessary ,prohibit mass social, political and religious and cultural congregations, processions, gatherings, meetings of the public,
(Action: Superintendent of Police Sundargarh, Rourkela/ All Tahasildar/ All EO Municipalities)

2. Close Cinema Halls, Swimming pools and Gymnasiums till further orders.
(Action: Superintendent of Police Sundargarh, Rourkela/ All Tahasildar/ All EO Municipalities)
3. Close all educational institutions, schools and colleges, ITI/ Engineering/ Coaching Centres whether govt or private till further orders. Hostels in all the residential schools managed by ST & SC Development Department shall continue to function.
(Action: All PA, ITDAs/ DEO, Sundargarh/ DWO, Sundargarh/ All Tahasildar/ All EO, Municipalities)
4. Convene special meeting of Gram Panchayat and Panchayat Samiti in order to sensitise public representative about COVID-19 and take their help and cooperation as to prevent Corona.
(Action: All BDOs)
5. Mission Shakti department will organise sensitisation of Women Self Help Group on precautionary measures and symptoms of COVID-19.
(Action: Additional PD, OLM, DRDA/ All BDOs)
6. Information and PR dept. will undertake setting of hoarding at prominent location in both Urban and Rural areas across the district.
(Action: DIPRO, Sundargarh, Rourkela & SDPRO, Bonai)
7. The Block Development Officer of the district will keep in ready safe shelter having capacity of 200 to 300 for suspected infected persons and provide the facilities of electricity, drinking water, toilet, mattress, medicine and if necessary cooked food for such person. Similarly the Executive Officer Municipalities take such steps within their jurisdiction for the suspected victims of COVID-19 as per Clause 34 (e) of the Disaster Management Act, 2005 .
The expenditure done on such activities would be booked and paid out of SDRF, after submission of certified bill and vouchers.
(Action: All BDOs)
8. The Chief District Medical & Public Health Officer, Sundargarh district and Director, Rourkela Govt. Hospital, Rourkela are to keep in ready the Quarantine and Isolation Facilities in their medical with reference to Letter No.I-137/2018-Mit II dt.11/03/2020 of NDMA, New Delhi and Letter no.934/OSDMA dt.13/03/2020 of Chief General Manager, OSDMA may be referred.
(Action: CDM&PHO, Sundargarh & Director, RGH, Rourkela)
9. The Commandant, 4th Battalion, OSAP, Rourkela keep their team in ready for deployment as and when required by the District Disaster Management Authority, Sundargarh.
(Action: Commandant ODRAF, OSAP, 4th Battalion, Rourkela)

Sub: Management of COVID-19 Pandemic regarding.

Madam/Sir,

I am to say that COVID-19 has now spread to more than 117 countries, including India and World Health Organisation (WHO) has declared it a global pandemic, the cabinet in its meeting held today has taken following decisions for prevention and containment of the disease:

1. All probable places of public congregation, gatherings, meetings, conferences, etc are to be regulated and restricted.
2. All educational institutions shall remain closed till 31.03.2020 except for holding examinations.
3. Non-essential official gatherings such as seminars, workshops, conferences will be cancelled.
4. Social gatherings and assemblies likely religious functions, marriage receptions, parties etc will be regulated by local authorities
5. Cinema Halls, swimming pools and gyms will be closed till 31.03.2020
6. The District Collectors, Municipal Commissioners and other local authorities will assess the nature and size of the assemblies in their respective

jurisdictions and prevent, restrict, regulate and otherwise control them by invoking provisions under the Epidemic Diseases Act, 1897 and the Code of Criminal Procedure, 1973.

7. Special meetings of Gram Panchayats and Panchayat Samitis will be held to sensitize people's representatives about COVID-19 and precautions to be followed and their roles in preventing/containing the pandemic.
8. Mission Shakti Department will organise sensitisation of Women Self Help Groups (in small group meetings) on precautionary measures and symptoms of COVID-19.
9. I&PR Deptt. will undertake settings of hoardings at all prominent locations in both urban and rural areas across the state upto Gram Panchayat level.

It is therefore, requested to issue directions accordingly to all the organisations, subordinates offices under your control to adhere to the above scrupulously.

ORDER: Ordered that this notification be published in the next issue of Odisha Gazette.




