For booking stall in Eat Right Street Food Mela 3.0 the Hotelier & Street vender is Rs.7000/- plus 18% GST.

So if any food vender interested to book stall, required to submit application form with proper document in requisite format in O/O Rourkela Municipal Corporation by Dt. 28.01.2025 at Room No. 58 by 11.00 AM.

Rules & Regulation, Documents with eligibility Criteria

- Food vender should be from Rourkela City only.
- Food vender should register with FSSAI License.
- If required stall allotted to the vender may be change by Rourkela Municipal Corporation.
- Successful applicants will have to deposit amount of Rs.7000/- plus 18% GST for all street vender through UPI/Debit card/NEFT/RTGS by Dt 30.01.2025. Otherwise allotment will be given to 2nd successful applicants.
- The decision of the RMC authority is final in all the cases and the authority has the right to cancel all the process without assigning any reason.
- During allotment of stall priority will be given to different street food.
- After receiving of payment, the payment will not be refunded for any reason thereof.
