- The applicant shall have PAN and valid GST Registration No. and must submit the photocopy along with the EOI. The same shall produce in original for verification at the time of opening of tender failing which the quotation will be rejected.
- Average annual turnover of INR 40 Lakhs (Rupees Forty Lakhs only) or above for the preceding 3 financial years (2018-19, 2019-20 & 2020-21) as per the statement duly certified by the Statutory Auditor / Chartered Accountant (FORM-II).
- Any Applicant which has been barred by any Central/ State Govt. agencies/ PUS in India, or any entity controlled by them, from participating in any project would not be eligible for participation.
- The Proposal must be submitted along with Form-I to IV and signed copy of the EOI document.
- No Consortium/ JV shall be allowed to participate in this EOI.
- The non-refundable Document fees of Rs.5000/- (Rupees Five Thousand only) must be submitted in the form of Demand-Draft drawn on a scheduled commercial bank in favour of "Commissioner, Rourkela Municipal Corporation, Rourkela" payable at Rourkela may be placed in an envelope.
- The sealed Bid shall be submitted to the Commissioner, Rourkela Municipal Corporation, Uditnagar, Rourkela, Dist.-Sundargarh (Odisha), PIN-769012 on or before 30.09.2022 by 1.00 P.M. (in any working day) as described above. The EOIs will be opened in presence of suppliers or their authorized representatives on the same day at 4.00 P.M. If the last date of submission, opening of EOI and other schedule happens to be a holiday, the next working day will be treated as the schedule for the same.
- E.M.D. (refundable) of Rs.1,00,000/- (Rupees one Lakh) only should be enclosed along with the EOI duly pledged in favour of Commissioner, Rourkela Municipal Corporation, Rourkela in shape Demand Draft from a scheduled commercial bank payable at Rourkela only. EMD of unsuccessful bidder will be returned without interest immediately after tender process is over. EMD of successful bidder will be retained as Security deposit and returned without interest after successful installation and fulfilling all the term & conditions mentioned in the bidding.
- The qualified Bidder/ agency have to complete the installation work within 30 days from the date of placement of work order. Any extension of time schedule will be at discretion of RMC Authority. If the selected Bidder fails to complete the job within the stipulated time period, RMC will be entitled to charge @1% of the accepted contract sum per week subject to a maximum of 10% of the accepted quoted price.
- Failing the service as per the terms and conditions of the EOI, lead to termination of the work order and forfeiting the entire amount of Security deposit.
- The qualified bidder has to install the signages at various places of Rourkela city.
- The location details will be supplied subsequently before installation of the signages.
- All the signages must meet the standard dimension and specification mentioned in bidding documents. All the signages must be uniform with respect to Size and design in all locations. Any kind of variation found in this regard will not be accepted and will lead to termination of the contract.

- The content design part of the signage is at the bidder scope. However, the content information to be collected from the office of the undersigned.
- The design of the content of each signage must be approved by the undersigned well before the finalization of the same. Only after formal approval the same may be placed in the signage.
- Any firm/bidder having experience in manufacturing & supplying of such types of display Boards to Government organizations will be given preference while selection of the bidder.
- Bidder found lowest quoted price will be awarded.
- Delivery, freight, commissioning and all other similar charges shall be borne by the Bidder and no separate payments shall be made of these accounts.
- The undersigned may engage one or more agencies with price negotiation.
