#### A. Introduction

Rourkela Municipal Corporation (RMC) invites Expression of Interest (EOI) from prospective applicant's i.e. Independent Artists, Art Educational Institutes and Non Governmental Organizations (collectively hereinafter referred as "Applicant") to undertake Street Arts, Wall Paintings, Public Art Works, Murals and Graffiti for city beautification under Rourkela Municipal Corporation, Rourkela.

RMC has identified certain road stretches, over bridges, buildings, important infrastructures etc. for work related to wall paintings, murals, graffiti and street art. The exact location and area for the above job to be decided by RMC while issuance of work order.

#### **B.** Scope of Work

The independent artists/ art education institutes/ non-governmental organizations are expected to play a positive and independent role in discharging its functions, thereby facilitating the smooth implementation and operation or the street art and murals project. Broadly, the scope shall encompass:

- 1. The program targets to paint large scale wall painting, murals and street art in high visibility landscapes like Flyovers – piers, underbellies and sidewalls, Building Facades, Water Tanks, and Walls etc.
- 2. The work shall include scrapping and cleaning of wall, painting of one primer coat and one weather seal coat (Asian Paints/ Dulux or equivalent brand), applying paint for mural art painting.
- 3. The agency shall do Wall Putti/ White Wash as base work before start of Art work, if required.
- 4. All the labour, manpower and equipments required for execution of the Art work shall be the responsibility of the selected applicants for undertaking the work. All costs related or incidental shall be borne by the selected applicant.
- 5. Daily monitoring of the nominated sites as earmarked.
- 6. Ensure adequate safety and environment management measures. The selected applicant shall take all precautions for safety of the manpower and labour employed by it in order to fulfill the scope of the work. RMC shall assume no responsibility in this regard.
- 7. RMC will decide the theme of the Art work or the selected agency will suggest the theme the painting. The agency must produce the prototype before execution of the work.

### C. Minimum Eligibility of the Applicants

Minimum eligibility criteria prescribed for selection of applicants are as mentioned below:

1. The Applicant must have completed 01 (one) similar projects/ assignments with minimum amount of Rs. 30,00,000/- (Rupees Thirty Lakhs only) each under a single contract/ Work Order/ Completion Certificate from any government/ reputed private agency area related to Street Art/ Mural Paintings.

#### Or

2. The Applicant must have completed 03 (two) similar projects/ assignments with minimum amount of Rs. 10,00,000/- (Rupees Ten Lakhs only) each under a single contract/ Work Order/ Completion Certificate from any government/ reputed private agency area related to Street Art/ Mural Paintings.

- 3. The Applicant shall be a single entity who is an independent artist, art education institute or Non Governmental Organization.
- 4. Any Applicant which has been barred by any Central/ State Govt. agencies/ PUS in India, or any entity controlled by them, from participating in any project would not be eligible for participation.
- 5. The applicant shall have PAN and valid GST Registration No.

Applicants not meeting the minimum eligibility criteria will not be considered for opening of financial proposal. Self-attested documents against point No. 2 and 3 (as per format provided in FORM-B and FORM-C respectively) must be submitted by the Applicant. All documents must be properly indexed.

However, for demonstration of experience as per Point No. 1 of this Clause, the applicant must attach work experience certificate from the client such as work order/ agreement copy/ completion certificate along with the format provided in FORM-D. All the above mentioned documents must be submitted separately in the Technical Proposal (Envelope-1).

#### Note:

- No Consortium/ JV shall be allowed to participate in this EOI.
- RMC reserves the right to reject any application without prior notice.

#### **D.** Brief description of the Selection Process

The Authority has adopted a Single Stage - Two Rounds selection process (collectively the "Selection Process") in evaluating the Proposals comprising technical and financial proposals to be submitted in two separate sealed envelopes. In the first stage, a technical evaluation will be carried out as specified in the EOI. Based on this technical evaluation, a list of short-listed Applicants shall be prepared and the financial proposal of only qualified applicants shall be evaluated. Maximum 03 (Three) Nos. of Independent Artists, Art Educational Institutes and Non Governmental Organizations will be empanelled. The Lowest quoting Independent Artists, Art Educational Institutes and Non Governmental Organizations will be empanelled along with L2 & L3 Independent Artists, Art Educational Institutes and Non Governmental Organizations at the L1 Price, if agreed. If not then the other Independent Artists, Educational Institutes and Art Non Governmental Organizations will get chance according to their position in financial standings.

#### E. EOI Submission Process

The Applicants would be required to furnish the information specified in the EOI document. Only those Applicants who will qualify the Technical Proposal Round will be considered for the Second Round, i.e. the evaluation of Financial Proposal.

All Applicants are required to submit duly filled Formats (Technical and Financial Proposal) in accordance with the guidelines set forth in this EOI. In order to enable the Applicants to prepare the proposal in a consistent manner and to

minimize misunderstandings regarding how Applicants' Proposals will be interpreted by RMC, the formats (Form A to D in Technical Proposal) in which Applicants will specify the fundamental aspects of their Proposals has been broadly outlined in the document. The evaluation of Technical Proposal

(Envelope 1) shall be carried out in accordance with the terms and conditions provided in this EOI document.

The Evaluation of the Financial Proposal-FORM E (Envelope 2) would be carried out on the basis of the evaluation of the Technical Proposal (Envelope 1) as per the criteria mentioned in the EOI. The Financial Proposal (Envelope 2) of short-listing Applicants would be opened.

The Applicant shall seal each of the envelopes duly marking each envelope as "TECHNICAL PROPOSAL FOR ART WORK" AND "FINANCIAL PROPOSAL FOR ART WORK" respectively and write the applicant details in the left corner of the envelope.

Both the envelopes (Envelope 1 and 2) should put in a single sealed cover contain the following information to be marked at the top in bold letters: **"EOI for empanelment of Agencies for undertaking Street Art, Wall Painting and Public Art Work"** and write the applicant details in the left corner of the envelope. #### F. EOI Document Fee

Non-refundable EOI document fee cost in shape of Demand Draft from any scheduled commercial bank in favour of Commissioner, Rourkela Municipal Corporation, Rourkela payable at Rourkela for Rs. 7,080/- (Rupees Seven Thousand Eighty only) including GST is to be furnished by the Applicant along with the Technical Proposal. Proposals without the requisite EOI document fee shall be treated as non-responsive and rejected.

#### Validity of Proposal

The Proposal shall be valid for a period of not less than 90 days from the Proposal Due Date.

## Period of Completion

The assigned work should be completed within 30 days from the date of issuance of work order. Any extension of time schedule will be at discretion of RMC Authority. Failure to comply the work within the time schedule mentioned above will invite the penalty of 10% from the project payment.

#### Language

The Proposal with all accompanying documents (the "Documents") and all communications in relation to or concerning the Selection Process shall be in English language and strictly on the forms provided in this EOI. No supporting document or printed literature shall be submitted with the Proposal unless specifically asked for and in case any of these Documents is in another language, it must be accompanied by an accurate translation of all the relevant passages in English, in which case, for all purposes of interpretation of the Proposal, the translation in English shall prevail.
