TERMS & CONDITIONS FOR HIRING OF VEHICLE

The following terms and conditions must be fulfilled by the successful bidder for providing 4 nos. of Truck mounted vehicles on hire on monthly rent basis.

1. The hired vehicles, during period of contact, shall have all necessary valid MV documents such as: - valid registration certificate, insurance certificate, valid pollution certificate, fitness certificate, valid contract carriage permit, proof of up-to-date tax payment etc. and DL of the driver available all the times. The Department / Office hiring vehicles or loss of life / injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hires shall be responsible for all such litigations.

2. Four vehicle should be Water Tanker (10,000 Ltr to 12,000 Ltr.). The vehicle must have Spray Facilities (Slow and High speed) having 30 ft water Pipe.

3. The vehicle must have achieved Daily running distance of 50 Km. in the assigned area and spray water in plants at least 3 trip per day.

4. The bill will be paid for the days it is engaged for the work during the month.

5. All the expenditure vehicles towards repair, replacement of spare parts, Gear box, Tyres & Tubes, Battery, lubricants, Fuel, Driver, Helper etc will be borne by the bidder.

6. The vehicles should be enabled with GPS tagging system by the agency.

- 7. It shall be the responsibility of the bidder to provide good drivers and the salary of the drivers shall be borne by the owner. The driver of the vehicle has a valid Driving License.
