- c. Vendor must submit photocopy of Weights & Measures Dealership Licence for selling the equipment.
- d. Vendor must submit photocopy of Weights & Measures Repairer Licence for installing the equipment.
- e. Vendor must have full-fledged office & service set up at Odisha.
