

Terms & Conditions

- The Bidder should have valid PAN Number and GST Number.
- The Bidder should be an authorized dealer/ supplier/ Distributor.
- The Bidder's should have an outlet at Rourkela and required document must be submitted along with the Bid.
- Each Bidder shall submit only one Tender as per the enclosed Bid Format in Annexure-II.
- The Bidders are required to submit Paper Cost of Rs.2240/- (Non-refundable) and Security deposit of Rs.20000/- in shape of Demand Draft separately in favour of the "**Commissioner, Rourkela Municipal Corporation, Rourkela**" payable at Rourkela. Bid submitted without Paper Cost & EMD shall not be accepted. The Security deposit will be forfeited, if a Bidder withdraws its Bid during the validity period of the Bid or fails to perform the contractual obligations as per the purchase order. The Security amount of the unsuccessful Bidder will be refunded after completion of Tender process.
- The Batteries should be delivered at Rourkela Municipal Corporation Office situated at Uditnagar or any other places mentioned by Rourkela Municipal Corporation.
- The quoted rate should be inclusive of all taxes and other charges like freight charges, loading, unloading and installation charges at specified places.
- The payment will be made to the bidder are subject to deduction of tax as per the Government Rule from time to time.
- Work order will be issued on phased manner as per the requirement.
- Price Validity: Bids shall remain valid for 180 days after the date of bid opening. A bid for a shorter period may be rejected by the purchaser as non-responsive.
- Warranty: Not Less than 12 Months on-site replacement warranty from the date of supply against any manufacturing defects.
- Replacement under warranty clause shall be made by the vendor free on all charges at site including freight, insurance, cost of work and other incidental charges.
- Time Limit: The Items should be delivered within 10 days from the date of issue of the purchase order.
- Payment: 100% payment shall be made within 15 days on the purchase order after successful delivery and installation on submission of Bills/Vouchers.
- The accepting authority reserve absolute right to reject any tender in full or in part or all tenders received; if no party is found suitable as per the requirement.
- The authority reserves the right to accept any tender, and to cancel/ abort the tender process and reject all tenders at any time prior to award of contract, without thereby incurring any liability to the Bidder, or any obligation to inform the affected agency without assigning any reason thereof.
