## Terms & Conditions

1. The Tender Enquiry shall be submitted in **two separately sealed envelopes (A-Technical and B- Financial Bid)** with a covered envelop super scribed on the top left corner of the envelopes as "**Supply & Installation of 12 Nos. Water Purifier of 120 Liter Storage Capacity at different 5T Schools**" and addressed to the Commissioner, Rourkela Municipal Corporation, Uditnagar, Rourkela, Dist.-Sundargarh (Odisha), PIN-769012.
2. The bidder has to submit Earnest Money Deposit (EMD) amounting to Rs. 50,000/- (Rupees Fifty Thousand Only) in the form of Demand Draft in favor of Commissioner, Rourkela Municipal Corporation, Rourkela. The EMD received from the tenderers will be returned without interest immediately after the process of award of contract is over. The bids received without EMD shall not be considered for technical evaluation.
3. **Performance Guarantee-** Performance Guarantee/ Security Deposit of 10% of total value will have to be deposited within 20 days of placing order in the form of Bank Guarantee from a Nationalized Bank. This shall be valid up to 90 days beyond warranty/ AMC period. Performance Guarantee will be returned without any interest after successfully completion of AMC period. This amount, however, be confiscated in case of refusal or failure to provide satisfactory services or backing out in midstream.
4. The Financial Bid form shall be submitted in Envelope-'B'
5. Both the Envelopes should be clearly marked as Envelope A & Envelope B With the words "**Supply & Installation of 12 Nos. Water Purifier of 120 Liter Storage Capacity at different 5T Schools**" super scribed on the top left corner of the envelopes which should also show the name and address of the bidder.
6. Only companies registered with ROC as supplier / manufacturer of RO plants and Department of Industries (NSIC) with valid Odisha GST number and ISO certification are eligible to quote.
7. The firm/supplier must be a local GST holder of Odisha. Bidder must have ISO Certification for doing business in supply and installation of water purification system inbuilt water cooler system.
8. If the bidder is a dealer, he must furnish the certificate of dealership of RO plant business issued by the manufacturing company.
9. The supplier must have experience in supply, delivery, installation and maintenance of water purification system inbuilt water cooler in any State Government Educational Institutions /any other Govt. Departments during last three years. The bidder should submit work completion certificate from the appropriate authority in support of his claim of installing the above number of water purification system inbuilt water cooler.
10. The bidder should not have been blacklisted by any State/ Central government and local authorities for breach of contracts in any supplies or work in past.
11. The bidders who are registered under NSIC Limited shall have special preference in the selection process per NSIC Rules.
12. The bidder should have a office and servicing unit at Rourkela.
