Illumination of Street Light and Beautification





Conduct of Field Level Training of AWWs & ASHAs on Urban Health & Nutrition Day (UHND)



There are 10 batches of field level training of AWWs & ASHAs on UHND was held from 18th November 2015 to 18th December 2015 in various dates in 3 phases at the meeting hall, SDH,Panposh. There are 373 nos. of AWWs out of 394 nos. belong to 3 different ICDS project were participated in the training. The participants were trained on packages of UHND services, guideline, various role of AWWs , ASHAs and some skills like measurement of MUAC, Stadiometer, Baby weighing scale(Sulter) etc. for increasing the capacity of workers for giving quality health services to Pregnant Women, Children 0-6 Yrs and lactating mothers. Similarly, 67 nos of ASHAs were also imparted training in two batches and rest 2 batches will be accomplished accordingly. The training was imparted by Dr.Puspamitra Mishra, SDMO cum Nodal Officer, NUHM, Rourkela, MOs of UPHCs like Dr. Manoj Pati & Dr. M.Sunita Debi, MO, URS: Dr. Subhashree Pattanaik, ICDS Supervisors of 3 different ICDS Projects, Mr. Niku Ranjan Pratihary, CPM, with active support of Mr.Himansu Sekhar Barik, Programme Assistant, NUHM, Rourkela.
